

# Zion Lutheran Scrip Program Agreement

Zion Lutheran School (referred to herein as “we”, “us”, and “our”) sponsors a scrip program which allows you to purchase scrip. 1. For administering the scrip program, we will retain 50% of the rebates received from your scrip purchases as an administration fee.
